A Message from the 2014 Board of Directors

The Board of Directors is currently at 8 members for 2014. The WPCAO Constitution gives the board the power to fill any vacancies which may occur among their number, providing that the any director so appointed shall hold office until the end of the term, but shall then be eligible for re-election. After much discussion, the majority of the Board felt that appointing from within the membership might appear to show partiality and could be contentious. An option for holding another General Meeting to have an election for the two vacancies among the membership would not be viable, as the minimum 21 days of notice will delay the board until the spring. Delaying the 2014 Board until March would cost too much precious time for fast approaching deadlines as the Board has already been held up by recent organization changes.

Instead, we intend to request much help and participation from the membership by way of committees and volunteers for various events and projects, and continue for the rest of 2014 with the 8 standing Board members. If a member is interested in volunteering to help out the WPCAO at any time, they are encouraged to contact the board.

The 2014 Board wishes to fully address member concerns that were brought forward at the AGM, January 12, 2014.

1. Eastern Canadian Pony Breeders Show

At the AGM, a commentary was presented to the membership, concerning the "Eastern Canadian Pony Breeder's Show" (ECPBS), July 26-28, 2013.

The details of this with reference to the BOD are as follows:

An original presentation was made to the AGM of 2011 pertaining to this upcoming show. After much discussion at the Board of Director meeting on February 19 th, 2012, the decision was made not to participate on an Association level –ie – help organize, pay for facility, pay for ribbons and contribute in other ways financially to run this show. They felt that spending approx \$2000.00 towards this venture, with no expectation of remuneration (entry fees), was not a fiscally responsible decision for the use of our member's funds. In a letter dated Wed. Apr 11, 2012, this information was communicated to the organizer, advising her that as an Association, we were unable to participate. Shows organized and run by our Association produce revenue and do not cost the members fees from the Association. For example, the cost for both shows of 2013 was \$3659.52, and the revenue made by the two shows was \$3704. Hosting these two shows did not result in a loss in the WPCAO funds and made the Association a small profit to go back into its coffers.

A response from the organizer was received on Saturday, April 21,2012, indicating that she had received our letter, and planned to move forward with her show, including the Welsh classes without the WPCAO's participation. As the decision had been made to not participate in the ECPBS in 2012, the 2013 Board did not have any more discussions pertaining to that show. There was no further correspondence from ECPBS in 2013, so the show fell off our radar.

The WPCAO Facebook Page administrator decided to post information regarding the ECPBS to make people aware of the show and entry deadlines on June 11 th, 2013. The post was viewed by 117 people, which is a larger audience than the newsletter would have reached.

Though the Board did not assist with finances or organization, there was no reason for WPCAO members or other Welsh Pony owners not to participate. The Board of Directors cannot speculate as to why individual members chose not to participate at the ECPBS.

In retrospect, the Board could have appointed this show as an Ontario High Point Show, but unfortunately, the ECPBS was not part of the 2013 Board's agenda. Hindsight is always 20/20 and the Board regrets that they did not offer this to the organizer at the time of the Board's decision in 2012.

2. Minutes

Approved minutes of the 2013 Board of Directors are available upon request. There are a balance of minutes that were not passed by the 2013 Board, and therefore not valid for publication. These have been declared received and filed, and cannot be referred to going forward. We sincerely apologize and assure you that in future we will make it a priority to provide the membership with all 2014 minutes once they have been approved in our quarterly newsletter.

As the Royal is an Equine Canada sanctioned show, the Royal has to follow the EC rules. However, the classes at the Royal do not correspond to all rules under the EC rules, such as a separate divisions for adults and juniors. There was a discussion about how rules can be changed. A request for this rule change will be brought up in National by a National representative from Ontario.

Alice motioned that a committee be formed to look at the EC Welsh rules and propose changes that will be brought to the board for review, seconded by Shirely. Passed and carried.

There was discussion to consider changing the name of the class at the Royal to eliminate the use of the whip rule until it is changed for the next year. By removing the word pleasure from the class, the rule could no longer be enforced.
